The minutes of the May 1st regular and May 23rd special meetings were approved.
The treasurer's report was approved.

Old Business

Nancy S. provided a proof of the sign for the centennial Shelter House project. The sign will include the Rotary Centennial logo.

Tate reported that a member has requested that the club ensure all our projects have signage. This will be an on-going project.

Nancy S. & Nancy L. reported that the invitations for the installation dinner will be mailed today. The event is June 28 at Marquette Cottage.

Tate requested that Lorene write a check to Young Life for \$1,000 as budgeted.

Jim C. expressed concerns regarding tables at Branding Iron. Lorene has talked to Sherry and she will have additional chairs available. The Board also agreed to do away with the head table to increase capacity. The President and speaker will sit toward the front and we will use our old podium. Jim M. suggested that we designate a contact person to communicate with Sherry. Jim C. volunteered himself and Gabe to be the contacts.

New Business

The Board received a resignation letter from Linda Sherman.

Tate reported that \$4300 has been paid to Rotary International through our Sustaining Member program. With these monies and additional points acquired through International, the club will be presenting 10 Paul Harris Fellows at the Installation dinner.

Phil and Helen have been collecting information sheets and pictures for the directory. The plan is to provide the directory to all members for free.

There was discussion regarding new member classification presentations. The Board agreed that Nancy S. will provide an overview on what a classification should include and we will move to a format of true classification presentations. The newsletter will continue to provide a biography of new members as has been done.

Tate asked that Kevin McQuerry's name be placed in the newsletter as a potential new member.

Phil presented survey results regarding club goals for 2007-08 as well as a proposed budget. There was some discussion regarding the budget. It will be presented to the new board in July for approval.

Jim M. suggested that whenever Rotary makes a donation to a group/organization that we make sure to invite a representative from that group to a meeting for a formal check presentation.
