The minutes of the January 8 board meeting, the January 9 regular meeting and the January 23 regular meeting were approved.

The Treasurer's Report was approved. Gabe will be moving monies out of the checking account into the money market account to earn a little interest. The checking account balance will be maintained at \$5,000. The Board will discuss contributing additional monies to the scholarship endowment at the end of the year. A suggestion was also made to move some of the money market funds to a 90-day CD for better interest.

Committee Reports
