Ballot issues would improve streets, sustain emergency services, reduce cost of water line replacement

The city of Harrisonville is asking voters to approve three ballot measures on Nov. 4 that address several critical needs. One of the main selling points is that non-residents will pay most of the cost. That was City Administrator Brad Ratliff's message to Rotarians last week as he explained each proposal and provided background on the rationale for bringing the measures to voters.

While the city has been very aggressive on seeking grants and leveraging existing resources, there comes a time, he said, when you have to face the fact that some services can no longer be sustained with existing resources as costs rise and grant opportunities diminish.



The first proposal would raise the city sales tax from 0.25% to 1.25%. "We are lower than everyone else," Brad said. Approval would help sustain critical fire and ambulance services, which now have to be subsidized by the general fund. One option is to get rid of these services and fold the city into a fire protection district, but that option would result in residents paying much higher property taxes. That's because the

fire districts levy their own property tax, typically over a dollar, whereas Harrisonville's total general fund property tax rate is 61 cents. City statistics on local retail sales, Brad said over 90% of sales in Harrisonville actually come from non-residents. This means that outsiders will be paying most of the freight. A simple major vote is required for passage.

The second proposal would create a one-penny fuel fee on gasoline sold in Harrisonville. All of the revenue must be used for city streets and roads. A lot of gas is sold in Harrisonville but all the tax revenue does not go to the city. Instead, it goes to Jefferson City where it is then distributed based on a city's population. As a result the city doesn't realize the benefit of having multiple truck stops and typically lower fuel prices.

Again, outsiders would be paying most of the additional penny fuel fee. "This is a real opportunity for us to capture revenue that we're missing out on," Brad said. A two-thirds majority vote is required for passage.

The third proposal addresses the long-delayed need to replace the main water line from Lake Harrisonville to the city's water treatment plant. The city intends to issue \$89 million in revenue bonds to finance the new water line and other water needs, such as a second water tower. Passage of this proposal would allow the city to qualify for interest savings estimated at \$7 million. Without approval that additional interest expense would have to be folded into utility rates, raising water rates for residents. A four-sevenths majority is required for passage.
