Once intent on a career in ag, Abby Lowrimore now provides financial advice

In one of our periodic classification talks, Abigail Lowrimore shared with fellow Rotarians last week the unlikely story of a small-town girl who made the transition from career in agriculture to becoming a financial advisor with Edward Jones.

Abby was introduced by fellow Edward Jones advisor Lori Watson, who recounted how Abby was referred to her by another advisor. "She reminds me of how I started (12 years ago)," Lori said. "She has heart, grit and soul."



Abby and her husband, a human resources executive at Russell Stover, live in Pleasant Hill with their Golden Retriever. She grew up in a similar-sized town, Mexico, Mo., the eldest of three children. Her parents were educators. "I was used to wrestling pigs and sheep, so I always thought I would go into agriculture."

She attended Northwest Missouri State University in Maryville, graduating in three years. Her first job was working in hydroponics at a greenhouse manufacturing company

helping big growers grow plants for resale through companies like Lowe's. Her next job was with a Lenexa company but a desk job was not for her. On the side, she started her own photography and videography business and worked part-time for her church, which was interrupted when she had hip and back surgery.

Then her mentor one day asked, "Have you ever thought about becoming a financial advisor." Abby had not, but she knew she loved helping people, so helping them with their finances and investments seemed like a good way to fulfill that desire.

One thing led to another until, under Lori's auspices, she opened her own Edward Jones office on Feb. 24. She and Lori share office space but have separate businesses. Now, Abby says, "I love what I do." In addition to her involvement with Rotary, Abby is active in the Harrisonville Chamber Foundation, the Peculiar Chamber and the Lions Club.

She has one more connection to Harrisonville — her brother-in-law, Nathaniel Orr, is the band director here.

Cindy and Jesi share 'Rotary Minute'

A periodic feature of our club meetings, the Rotary Minute, led by Cindy Greenwell, resumed at last week's meeting as Cindy was joined by Jessica Junge to share tidbits of information important to both new and veteran Rotarians.

Cindy refreshed members on our annual Christmas Adopt a Family project, providing clothing, gifts and toys for a needy family. The referrals come through either Bright Futures or the Cass County Toy Shop. Look for details as reach the holiday season.

Jesi refreshed members on our quarterly billing details. For a regular member, the statement includes \$165 for meals, \$30 for Rotary dues and an optional \$25 to The Rotary Foundation, called a Sustaining Member. Over 10 years, the quarterly contributions add up to \$1,000, which makes the member a Paul Harris Fellow.

The quarterly statements are different for corporate members, whose meals are charged based on their attendance at \$13.25 per meal. Jesi also reviewed some of the club's recurring donations to various organizations, which are funded in part by meal profits. This includes a \$5,000 yearly contribution over five years going to a Parks & Rec account for our Miracle Field 50th anniversary project.

Under her leadership, the club assembled and distributed comfort kits—stocked with clothing, toiletries, and snacks—for victims of violent crime through The Victim Center.

"Many victims leave traumatic situations with nothing," she says. "A comfort kit may seem small, but it provides dignity and a first step toward healing. Rotary helped make that possible."

Brady's Rotary service represents more than club meetings—it's a deeply personal mission. "It's these moments that remind me why I say yes," she reflects. "Rotary connects me with others who care, who want to serve, and who believe we can make a difference together."

Known for her wide-ranging community involvement, Brady also volunteers with Help Give Hope, Leadership Springfield, and the Springfield Area Chamber of Commerce. Her deep commitment to service has not gone unnoticed—she is a recipient of Great Southern Bank's Bill and Ann Turner Distinguished Community Service Award, one of the bank's highest honors.

"I was humbled to be recognized," Brady says. "So many of my colleagues give so much. To be named among them is one of my proudest moments."

For Andrea Brady, Rotary is not just a club—it's a calling. Through mentorship, advocacy, and leadership, she continues to advance the mission of Rotary in Springfield and beyond.
