Video of club projects up to 1995 shows how Rotary has touched many lives

S ome 26 years ago in 1995, John Foster documented on video a long list of Rotary projects from the club's inception in 1977 - an 18-year-period that some would argue was the club's heyday. In those early years, he said, it seemed as though "there was no hill too steep and no ditch too deep."

His point was simple: Harrisonville Rotary has touched many lives in our community.

"I wouldn't doubt that, in today's dollars, the Harrisonville Rotary Club has invested close to a million dollars in this community," John said. "I encourage you, when there's a club project, get involved."

Although the video is dated, John is planning to update it with projects the club has undertaken from 1995 forward.

The video he showed began with scenes of the "Welcome to Harrisonville" signs and the City Park sign that Rotary built. These remain impressive monuments at two entrances to the city and at the City Park entrance on Ash and Lexington streets.

He then traced a wide range of significant building projects that the club tackled. These included the North Park Arena, bleachers, and concession stand. He touched on the club's involvement with the Sharp-Hopper Log Cabin, the North Park Activity Center building, the J.W. Brown ballfields, the painting of several houses in older neighborhoods, and our support of the Casco Area Workshop's annual picnic.

The video ended with scenes of birdhouses the club built — about 100 of them — for the 1985 Rotary International Convention in Kansas City. One of the houses was built by our Rotary Youth Exchange student from Japan.


The club is currently narrowing down a list of potential "signature" projects for the club to undertake in the years ahead.

Harrisonville Rotary Club Memberships

(Active)

Individual, Corporate, Entrepreneur Membership

Individual

- \$135 dues quarterly (includes dues, meals, sustaining member)
- All member privileges (eligible to hold office, vote, participate freely)
- Stated 75% attendance requirement

Corporate

- Meals billed at \$135 Quarterly, \$27.50 dues invoiced quarterly per individual seat under the membership, additional meals invoiced when multiple individuals attend weekly lunch meeting.
- All member privileges (eligible to hold office, vote, participate freely)
- Stated 75% corporate attendance requirement

Entrepreneur

- \$95 dues quarterly (includes dues, meals),
- All member privileges (eligible to hold office, vote, participate freely)
- Stated 75% attendance requirement
- . Individual must be newly in business, is eligible for up to 2 years, and qualifies at the Board's discretion

(Semi-active)

Individual Retired Membership

- \$45 dues quarterly (includes dues only)
- Meals invoiced per attendance
- All member privileges (eligible to hold office, vote, participate freely)
- No attendance expectations
- · Individual qualifies at the Board's discretion

(Inactive)

Individual Leave of Absence Membership

- \$45 dues quarterly (includes dues only)
- Individual does not qualify for full member privileges (eligible to hold office, vote, participate freely)
- No attendance expectations
- Individual qualifies at Board's discretion for up to six months

Honorary Individual Membership

- No dues
- Individual does not qualify for full member privileges (eligible to hold office, vote, participate freely)
- No attendance expectations
- Per RI, must be reviewed and approved by the Board annually
